

IMPORTANT NOTICE FOR FD HOLDERS

WHO HAVE FILED CLAIMS UPTO 7TH MARCH 2023

To update their bank account details with Registrar of the Fixed Deposit

1. Background

This is in reference to the treatment to the dues of the Fixed Deposit Holders (the “FD Holders”) of the Jaypee Infratech Limited (the “Company”) who have submitted their claims in the Corporate Insolvency Resolution Process of the Company. It is to be noted that the order dated 07.03.2023 passed by the Hon’ble National Company Law Tribunal approving the resolution plan submitted by the Lakshdeep Investments and Finance Private Limited and Suraksha Realty Limited (the “Successful Resolution Applicant”, hereinafter “SRA”) for the Company has been upheld by the Hon’ble NCLAT by order dated 24.05.2024 in the matter of Civil Appeal (AT)(Ins) No. 493 of 2023. The said Resolution Plan is binding on all the stakeholders of the Company including the Fixed Deposit Holders (“FD Holders”). Pursuant to the said order of the Hon’ble NCLAT, the SRA implemented the Resolution Plan with effect from 24.05.2024.

We wish to inform that in terms of the Resolution Plan, the Company has initiated the payment of First Instalments to FD holders on 25.11.2024, to the Bank Account details available with the Registrar. The Second and third instalments are due on 24.05.2025 and 24.11.2025. It may be noted that in some cases the payment got rejected due to various reasons.

Further, the Company has given an option to the Fixed Deposit holders to claim early payment with small deduction, details of the same are available on the website of the Company. The Company verifies the documents received for early payment and release payment at the end of every month.
