

IMPORTANT NOTICE FOR FD HOLDERS

1. Background

This is in reference to the treatment to the dues of the Fixed Deposit Holders (the “FD Holders”) of the Jaypee Infratech Limited (the “Company”) who have submitted their claims in the Corporate Insolvency Resolution Process of the Company. It is to be noted that the order dated 07.03.2023 passed by the Hon’ble National Company Law Tribunal approving the resolution plan submitted by the Lakshdeep Investments and Finance Private Limited and Suraksha Realty Limited (the “**Successful Resolution Applicant**”, hereinafter “**SRA**”) for the Company has been upheld by the Hon’ble NCLAT by order dated 24.05.2024 in the matter of Civil Appeal (AT)(Ins) No. 493 of 2023. The said Resolution Plan is binding on all the stakeholders of the Company including the Fixed Deposit Holders (“**FD Holders**”). Pursuant to the said order of the Hon’ble NCLAT, the SRA implemented the Resolution Plan with effect from 24.05.2024.

We are pleased to inform you that in terms of the Resolution Plan, the SRA has initiated the payment of First Instalments to FD holders on 25.11.2024, whose Bank Account details are available. Further, the Company has given the Fixed Deposit holders an option to request early payment and many Fixed Deposit holders have opted/are opting for the same. The Company is verifying the documents received and is expected to release payment in the month of December, 2024.
