

### Jaypee Infratech Limited

#### List of Home buyers who have submitted their claims after December 6, 2019 and not a part of Committee of Creditors

The Committee of Creditors ("CoC") of Jaypee Infratech Limited has been reconstituted as on April 14, 2021. In the order dated March 24, 2021, Hon'ble Supreme Court has placed the following order:

*"225.3. It is made clear that the IRP shall not entertain any expression of interest by any other person nor shall be required to issue any new information memorandum. The said resolution applicants shall be expected to proceed on the basis of the information memorandum already issued by IRP and shall also take into account the facts noticed and findings recorded in this judgment."*

Pursuant to the above, for the purpose of Re-constitution of CoC, the CoC constituted as on December 6, 2019 has been considered. However, the home buyers claims wherein the sub-lease deed has been executed till March 14, 2021 have been reduced from such CoC as on December 6, 2019. The claims received post December 6, 2019 have not been considered for the purpose of CoC constitution pursuant to the aforementioned order.

*Please note that these home buyers are not part of CoC as we have not received the claim forms within prescribed period. However, they continue to remain allottees as per the books of the corporate debtor.*
