- Notes : 1 The standalone result of the Company comprises of only one segment i.e. Yamuna Expressway Project, an integrated project which interalia includes construction, operation and maintenance of Yamuna Expressway and rights for land development of 25 million sq. mtrs. along the expressway.
 - On August 9, 2017 Hon'ble National Company Law Tribunal (NCLT), Allahabad bench, had admitted the petition for initiating Corporate Insolvency Resolution Process (CIRP) under the Insolvency and Bankruptcy Code, 2016 (IBC) vide its Order dated August 9, 2017 and appointed Mr. Anuj Jain as the Interim Resolution Processional (RP) in terms of the IBC. Mr. Anuj Jain was subsequently confirmed by the Committee of Creditors (CoC) as the Resolution Professional (RP). The matter is also pending in Hon'ble Supreme Court in Writ Petition No. 744/2017. Any outcome of CIRP is subject to final decision of Hon'ble Supreme Court in the above matter.

Accordingly, Sh. Anuj Jain took control of the management and operations of the Company. As the powers of the Board of Directors have been suspended, the above result have not been adopted by the Board of Directors however, the same have been signed by Shri Manoj Gaur, Chairman Cum Managing Director of the Company, confirming, accuracy & completeness of the results. These financial statements have thereafter been taken on record by the RP on May.17, 2018 for filing with the stock exchanges.

- 3 The Company has negative revenue for the year ended March 31, 2018, primarily, pursuant to independent consultant's report on balance cost to complete.
- 4 As the Company is under Corporate Insolvency Resolution Process, the financial statements have been presented on a 'going concern' basis. As per the Corporate: Insolvency Resolution Process (CIRP), Resolution Plan submitted by prospective Resolution Applicant has not been approved by COC within the mandatory 270 days period. Until further direction by the Hon'ble Supreme Court, the financial statements have been prepared on a going concern basis. The Interest on the debt for the period 09.08.2017 to 31.03.2018 provided in the books of accounts and charged to statement of profit & loss, is subject to the outcome of CIRP.
- 5 Management reviewed the deferred tax assets/ liabilities on temporary differences between the tax bases of assets and liabilities and their carrying amounts for financial reporting purpose at reporting date and in view of virtual certainty of taxable profits in near future and availability of deferred tax assets to be set off;however, as the Company is under CIRP, the deferred tax(net assets) for the reporting period i.e. 01.04.2017 to 31.03.2018 have not been considered.
- ⁶ Figures for the quarters ended 31st March,2018 and 31st March,2017 represents the balancing figures between the audited figures for the full financial year and published year date figures up to third quarter of the respective financial year.

Previous quarters/ year figures have been reworked/regrouped/rearranged wherever necessary to confirm with those of current quarter/ year.

In making those risk assessments, the auditor considers internal control relevant to the company's preparation and fair presentation of the Statement in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the internal controls. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the Statement.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.



3. Opinion

In our opinion and to the best of our information and according to the explanations giving to us, the Statement:

- (i) includes the results of the Jaypee Healthcare Limited, a subsidiary of the company in so far as they relate to the consolidated financial results in the statement;
- (ii) is presented in accordance with the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as modified by circular no. CIR/CFD/FAC/62/2016 dated 5thJuly, 2016; and
- (iii) gives a true and fair view in conformity with the aforesaid Indian Accounting Standards (Ind AS) and other accounting principles generally accepted in India of the Standalone net loss and total comprehensive income and other financial information of the company for the year ended 31st March, 2018

4. Emphasis of Matter

We draw attention to the following:

- (i) Note no. 2 regarding Corporate Insolvency Resolution Process(CIRP) initiated under Insolvency and Bankruptcy Code, 2016 ('the Code') and the outcome of the CIRP is subject to decision of Hon'ble Supreme Court; and
- (ii) Note no. 4 regarding presentation of financial statements on a going concern basis.

Our opinion is not modified in respect of the above matters.

We did not audit financial statements of a subsidiary whose financial statements reflect total assets and total net assets as at 31st March 2018, total revenues and net cash inflow/(outflow) for the year ended on that date considered as under in the statement based on audited financial statements by other auditors:
