**IMPORTANT NOTICE FOR HOMEBUYER of INACTIVE/CANCEL**  
**UNITS**

**Subject: Refund of Payment in accordance with Clause 17.28 of the Resolution Plan.**

As you are aware, the Order dated 07.03.2023 passed by the Hon'ble NCLT approving the Resolution Plan of Suraksha Group, the Successful Resolution Applicant ("SRA"), has been upheld by the Hon'ble NCLAT by order dated 24.05.2024. Although some parties have challenged the order of Hon'ble NCLAT before the Hon'ble Supreme Court, in the interest of stakeholders such as homebuyers, of Jaypee Infratech Limited, the SRA has commenced implementation of the Resolution Plan with effect from 24.05.2024 subject to the final outcome of the proceedings before the Hon'ble Supreme Court or any direction that may be passed by the Hon'ble Supreme Court during the pendency of the appeal.

We are pleased to inform you the SRA is in the process of taking steps, in accordance with Clause 17.28 of the Resolution Plan, for making refund to allottees of Jaypee Infratech Ltd who have opted for refund pursuant to cancellation of their agreements(s). Clause 17.28 of the approved resolution plan is reproduced below for your reference:

*17.28. The Home Buyers who have claimed refund against the Corporate Debtor pursuant to cancellation of their agreement(s) with the Corporate Debtor shall be paid their admitted claims i.e. Rs. 65 crores (as on 05.04.2021) in two equal annual instalments from the Approval Date, without any interest.*

In terms of Clause 17.28, refund will be made by SRA of the paid principal amount in two equal annual instalments from the Approval Date, without any interest.

As part of SRA's commitment to provide early resolution, and to support our valued homebuyers, the SRA is offering an alternative option to the homebuyers of payment of refund amount in a single tranche rather than in two instalments over two years, subject to the present value of principal amount calculated at a discount rate of 8% per annum. This goodwill gesture is intended to expedite the refund process and ensure that homebuyers receive their refunds at the earliest convenience. We are enclosing a Form with this communication to enable you to exercise your option either to receive refund of full amount in two equal instalments over two years as provided in Clause 17.28, or to receive the refund in one bullet payment subject to the present value of principal amount calculated at a discount rate of 8% per annum. Please fill the attached form by checking one of the two options, and filling other details mentioned therein, and send it by email to [customercare@jilindia.in](mailto:customercare@jilindia.in).

Please note that SRA is committed to payment of refund in accordance with the Resolution Plan and exercise of the alternate option offered by SRA is entirely at your discretion.

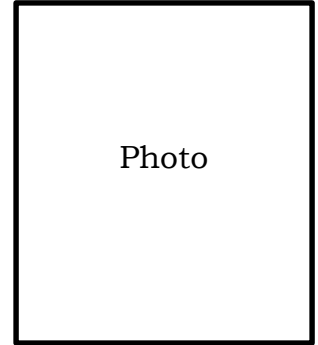
