

# US, China bicker over 'extravagant expectations' in trade deal

**CHINA ACCUSED THE US** on Monday of harbouring "extravagant expectations" for a trade deal, underlining the gulf between the two sides as US action against China's technology giant Huawei began hitting the global tech sector.

Adding to bilateral tension, the US military said one of its warships sailed near the disputed Scarborough Shoal claimed by China in the South China Sea on Sunday, the latest in a series of "freedom of navigation operations" to anger Beijing.

Alphabet's Google has also suspended business with China's Huawei Technologies that requires the transfer of hardware, software and technical services, except those publicly available via open source licensing, a source familiar with the matter told Reuters on Sunday, in a blow to the company that the US government has sought to blacklist around the world.

Shares in European chip-makers Infineon Technologies, AMS and STMicroelectronics fell sharply on Monday as worries the Huawei suppliers may suspend shipments to the Chinese firm due to the US blacklisting of it last week.

The Trump administration's addition of Huawei to a trade blacklist on Thursday immediately enacted restrictions that will make it extremely difficult for it to do business with US counter-

parts. In an interview with Fox News Channel recorded last week and aired on Sunday night, Trump said the US and China "had a very strong deal, and they had a good deal, and they changed it. And I said that's OK, we're going to tariff their products."

In Beijing, Chinese foreign ministry spokesman Lu Kang said he didn't know what Trump was talking about. "We don't know what this agreement is," the United States is talking about. Perhaps the US has an agreement they all along had extravagant expectations for, but it's certainly not a so-called agreement that China agreed to," he told a daily news briefing.

The reason the last round of China-US talks did not reach an agreement is because the US tried "to achieve unreasonable interests through

extreme pressure", Lu said. "From the start this would not work." China went into the last round of talks with a sincere and constructive attitude, he said.

"I would like to reiterate once again that China-US economic and trade consultation can only follow the correct

track of mutual respect, equality and mutual benefit to there be hope of success."

No further trade talks between top Chinese and US trade negotiators have been scheduled since the last round ended on May 10 — the same day Trump raised the tariff

rate on \$200 billion worth of Chinese products from 10%. Trump took the step after the US said China backtracked on commitments in a draft deal that had been largely agreed to.

**Stern tone**  
Since then, China has struck a

sterner tone, suggesting that a resumption of talks aimed at ending the 10-month trade war between the world's two largest economies was unlikely to happen soon. Beijing has said it will take "necessary measures" to defend the rights of Chinese companies but has not said whether

it is right to boycott Apple and said he was not throwing away his iPhone. "The US spares no efforts to subdue Huawei, out of personal belief, I chose to support the well respected company by using its product," Hu Xijin tweeted. —REUTERS

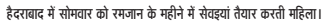

पलानीस्वामी का यह बयान ऐसे समय में आया है, जब विपक्ष और तमिल समूह आजीवन कारावासी की सजा काट रहे सातों दोषियों को रिहा किए जाने की फिर से अपील करने लगे हैं। सुप्रिम कोर्ट ने 1991 में पूर्व प्रधानमंत्री के साथ मारे गए लोगों के परिजन की उस याचिका का हाल

में निपटारा किया था, जिसमें दोषियों की रिहाई का विरोध किया गया है। राजीव गांधी के साथ मारे गए लोगों के परिवारों ने सातों दोषियों को रिहा करने के 2014 में लिए गए तमिलनाडु सरकार के फैसले का विरोध किया था।

पलानीस्वामी ने कहा, 'हमने लोगों की भावनाओं के आधार पर फैसला किया, कैबिनेट में प्रस्ताव पारित किया और उसे राज्यपाल के पास भेजा। हम उम्मीद करते हैं कि वे कदम उठाएंगे।'

पालघर के जिलाधिकारी प्रशान्त नारायण ने कहा कि बीते साल खराब मौसम के कारण जिले के जलाशयों में उनको कुल षडंशर क्षमता का रिफे 22 भीतर पानी था। अब तक पालघर में 333 गांवों के 51,174 किसानों को 21.09 कोरु रुपए मुसुआवे के तौर पर दिए जा चुके हैं। राख के पालघर प्रथम विभाग के अधास सचिव मनीषा धर्मा ने यह संरुट की समीक्षा के लिए सहाईत में जिले का दौरा किया था और आशवासन दिया था कि रिफिले से निपटने के लिए धन को कोई कमी नहीं है।

प्रदेशीय हरित पंचाट (एनजीटी) ने उत्तराखंड सरकार को यह सुनिश्चित करने का निर्देश दिया है कि गंगा नदी व उसकी सहायक नदियों के किनारों पर कोई भी अवैध तरीके से शिथिल लगा कर न हो। एनजीटी प्रमुख न्यायमूर्ति आदर्श कुमार गोयल प्रतिबंधित करने का निर्देश दिया। पीठ ने आगाह किया कि कारवाई करने में विफल रहने पर नदी में अपशिष्ट या गंदे पानी छोड़ने के लिए जिम्मेदार व्यक्तियों या अधिकारियों से मुआवजा वसूला जाएगा।

पीट ने कहा कि यह मुआवजा नसीहत के बजाए बर्बाद करने वाला और पुगनी स्थिति बहाल करने की कोशिश करने के लिए पर्याप्त होना चाहिए। ऐसा करने से यह सुनिश्चित करने के लिए जरूरी है कि गंगा नदी को प्रदूषित करना अब फायदेमंद सौदा नहीं होगा। सुप्रीम कोर्ट ने इस पंचाट की ओर से पिछले 3 सालों में बार-बार दिए गए निर्देश केवल कागज पर तक सीमित नहीं रहने चाहिए।
