नवलनी को जेल में रखने का आदेश

मास्को, 2 फरवरी (एजंसी)।

मास्को की एक अदालत ने रूसी विपक्षी नेता अलेक्सेई नवलनी को प्रोबेशन के उल्लंघन का दोषी पाते हुए जेल में रखने का आदेश दिया है। नवलनी ने अदालत में सुनवाई के दौरान कहा कि सरकार लाखों लोगों को डराने के लिए उनके खिलाफ कार्रवाई कर रही है।

राष्ट्रपति व्लादिमीर पुतिन के आलोचक नवलनी (44) को जर्मनी से लौटने पर 17 जनवरी को गिरफ्तार किया गया था। नर्व एजेंट (जहर) के हमले के बाद वह जर्मनी में पांच महीने से उपचार करा रहे थे और उन्होंने जहर दिए जाने के लिए रूस की सरकार पर दोष मढ़ा था। हालांकि रूस की सरकार ने उनके आरोपों को खारिज कर दिया था और कहा था कि जहर दिए जाने के सबूत नहीं मिले।
